

We are excited to welcome our scholars back on campus for in-person learning! The health and wellness of all scholars and staff remain our top priority. **Please read and sign below so that we can work together to ensure that all scholars, staff and families are aware of the expectations of safely participating in our on-campus learning environment.** Meeting these expectations is required to participate in our in-person learning so that we can ensure we are preventing the spread of COVID-19 to the greatest extent possible and so that we are in compliance with all recommendations provided by the Sacramento County Health Department.

Health Screenings

1. Scholars should be screened at home each day. Scholars should not come to school if they are experiencing any symptoms such as a fever, sore throat, cough, shortness of breath, vomiting, etc. Scholars should not come to school until they have been symptom-free for 72 hours.
2. When scholars arrive on campus, they must enter their grade-level specific entry point, participate in a health screen and get their temperature checked. Scholars will not be permitted to attend school if they have a fever above 100.3 or if they self-report that they are experiencing any sick symptoms.

Masks

1. Scholars must wear a face mask that properly covers their nose and mouth for the entire school day.

Social Distancing

1. Scholars must remain 6 feet apart from their peers while in class and during transitions. Classroom set ups have been modified so that all desks are situated 6 feet apart from others. Scholars may not reposition desks. Scholars must wait 6 feet apart while in line for arrival, breakfast, lunch and during transitions. Social Distancing stickers have been placed on the ground to guide social distancing.

Daily Must Haves

1. Scholars must arrive in their complete school uniform every day.
2. Scholars must wear a face covering every day.
3. Cell phones are not permitted during the school day while on campus.
4. Scholars must bring their own water bottle as water fountains are currently not permitted.

Visitor Policy

1. No visitors are allowed on campus. Families are welcome to call the front office or stop by the front office but may not go past this location. While in the front office, social distancing must be followed and a face covering must be worn.



Dismissal

- 1. Scholars must exit through their grade-level exit point. If scholars are walking home or riding the bus, they must immediately depart campus to head home. If scholars are waiting for a ride, they must wait in their grade level area, wearing a mask and socially distanced.
- 2. All scholars must be picked up on time each day. We cannot have scholars left unsupervised as we are required to ensure that if scholars return to the in-person learning environment that the most important preventative measures are in place at all times- face coverings, social distancing and cohorting. We cannot have scholars left unsupervised on campus after dismissal.

Reporting of A COVID-19 Positive Test

Communication

- 1. It is incredibly important that we have a way to get in contact with a parent or guardian each day. In the event that we have an urgent situation, such as a scholar becoming ill or a scholar not complying with our health and safety guidelines or a need to transition to distance learning, we need to ensure you receive the communication in a timely manner. Please ensure your contact information is up to date at all times and please take all phone calls that come from the school.
